| Roof Drains        | Roof drains and leaders Roof drains should not be connected to the sanitary sewer but should discharge to the ground outside of a building. If the roof drains are connected to the sanitary sewer, disconnect them, plug any open connections to the sanitary sewer using a non-shrink permanent material, and redirect the roof drains onto the ground outside the building.                                                                              |      |      |
| Foundation Drains  | Foundation drains are underground pipes that collect storm water from around the base of a building and into a sump basket, where it is then pumped outside of the building. | Sump Pumps         | Sump pumps are designed to capture surface or ground water that enters basements or crawl spaces and pump it away from the house. The basic sump system includes drain tile, a sump pit, a sump pump, a float or switch, and a drain line. | <b>Purpose</b> <p>The following instructions and standards are intended for property owners and their contractors when choosing to use a private contractor to complete the Point of Sale Sanitary Sewer Service Inflow and Infiltration (I/I) Inspection. Private inspection contractors will need to complete the inspection using the City of Orono's Inflow/Infiltration Inspection Form, available on the City website. Inspectors will require access to the basement or lowest level in the home or building and access to all sewer cleanouts, sump pump(s), and sump pump plumbing. The televised portion of the I/I inspection is to note defects in the sanitary sewer lateral, which result in infiltration and ex-filtration. The purpose of the private property inflow and infiltration (I/I) inspection is to reduce the flow of clear water into the sanitary sewer system via cross connections (inflow) from sump pumps, foundation drains, roof leaders, cisterns, and other clean water sources connected to the sanitary sewer system. In addition, the program aims to reduce indirect flow of clean water into the sanitary sewer system (infiltration) through pipe and pipe joint defects.</p> |                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                     |

| <ul style="list-style-type: none"><li>• Inflow/Infiltration Compliance Inspection form must be completely filled out for the inspection to be complete.</li><li>• The inspector is required to note all defects and footage location in the sanitary sewer lateral on the compliance inspection form and an audio description recorded on USB Thumb drive or hard drive.</li><li>• The sewer service inspection must the service pipe from before it exits the building to the sewer main.</li><li>• All connections must be verified by flowing water into drains, referencing the source, and reporting them on the video</li><li>• Any connection that cannot be verified is considered to be an unknown connection and must be exposed to verify source.</li><li>• All cleanouts are required to be opened and inspected (include photos of the opened cleanout riser); cleanout inspection requires documented footage location on the form and audio description recorded on USB Thumb drive or hard drive.</li></ul>                                                                                                                                                                                              | <ul style="list-style-type: none"><li>• All floor drains will need to be opened and inspected (include photos of the drain, the surrounding area, and the nearest foundation wall).</li><li>• Any foundation drains found will need to be opened and the discharge point verified (include photos).</li><li>• All external drains will need to be opened and the discharge point verified</li><li>• Defects/items that require documentation include, but are not limited to:<ul style="list-style-type: none"><li>➢ roots</li><li>➢ offset pipe joints</li><li>➢ mineral deposits</li><li>➢ unknown deposits</li><li>➢ sag/pipe deflection</li><li>➢ cracked pipes</li><li>➢ chipped pipes</li><li>➢ Pipe size transitions</li><li>➢ length of service</li><li>➢ location of all cleanouts</li><li>➢ broken / damaged or missing pipe</li><li>foundation drain connections (including photos).</li></ul></li></ul> |

Total number of sump pumps must be noted.</li> <li>Sump pump discharge piping is required to be rigid pipe. Flexible pipe, shut-off valves, plumbing tees, and wyes are not allowed.</li> </ul> | <ul style="list-style-type: none"> <li>Correctly plumbed sump pump discharges outside of the building using rigid pipe.
