### **TREE PRESERVATION EASEMENT AGREEMENT**

THIS AGREEMENT (the "Agreement") is made as of 2010, 2018, by and between JUDSON M. DAYTON AND SHELLEY MYDRA-DAYTON, as trustees under the Judson M. Dayton Revocable Trust Agreement, dated October 31, 1988, as to an undivided 2/3 interest, and SHELLEY MHYDRA-DAYTON AND JUDSON M. DAYTON, wife and husband, personally, as to an undivided 1/3 interest (collectively, the "Grantor"), and the CITY OF ORONO, a Minnesota municipal corporation ("City").

The Grantor, in consideration of good and valuable consideration paid by the City, the receipt and sufficiency of which are hereby acknowledged, hereby grants the City a permanent tree preservation easement over, under, and across the premises described in the attached Exhibit "A" (the "Subject Property").

The Grantor, for itself, its successors and assigns, agrees that the following are prohibited in perpetuity on the Subject Property:

- A. Constructing, installing, or maintaining anything made by man, including but not limited to buildings, structures, walkways, clothes line poles, and playground equipment within the dripline of a tree, when such activities would damage the tree.
- B. Cutting or removing trees; provided, however, removing dead trees, trimming trees to maintain health, removing diseased trees, and removing selected trees approved by the City, when required to allow sunlight to penetrate limited areas on the Subject Property, may be undertaken.
- C. Excavation or filling when these activities would contribute to damage or loss of protected trees.

Grantor, for itself, its successors and assigns covenants with the City, its successors and assigns, that it is well seized in fee title of the Subject Property; that it has the sole right to grant and convey the easement to the City; that there are no unrecorded interests in the Subject

Property; and that the owner of the Subject Property from time to time will indemnify and hold the City harmless for any breach of the foregoing covenants.
