## DECLARATION OF RESTRICTIVE COVENANT

THIS DECLARATION OF RESTRICTIVE COVENANTS (the "Declaration"), is made this 21 day of, 2018, by the undersigned parties, representing all of the owners in fee of the land hereinafter described, lying in Hennepin County, Minnesota.
WHEREAS, Loug Acl Close are the fee owners of real property legally described on the attached Exhibit A; and
WHEREAS, property owners have applied to the City of Orono for Permit No. PASIES CONTROLLED TO Install a toilet and sinks in an accessory structure; and
WHEREAS, the undersigned parties desire to impose upon and subject said land to certain covenants, conditions, restrictions and reservations for the benefit of said land and its present and future owners;
NOW, THEREFORE, the undersigned parties hereby declare, impose upon, create and establish the following covenants, conditions and restrictions upon the property:
1. PROHIBITION ON USES.
A. The accessory structure containing the toilet and sinks shall not be used as dwelling unit or guest house.
B. No bathing facilities shall be installed in the accessory structure.
C. Used for a home occupation unless specifically approved by the city or if allowed by this Code.
