INSPECTION SUMMARY:

Does the sewer show any signs of damage or defect? If so, what type of attention is needed and how severe: This pipe showed no structural concerns such as cracks or breaks. This line also displayed good pitching levels with a small stream of water leading to the city sewer connection.

Any Evidence of Repairs or Updates made to this pipe yet?

This pipe is a mixture of PVC and Cast Iron.

Does This Line Require a Drain Cleaning now or when can I expect maintenance to be needed? This pipe should be fairly maintenance free but i would recommend cleaning the cast iron portion every 6 to 8 years for corrosion build up.

Any Additional Info or Tips?

I recommend refraining from flushing items such as flushable wipes, feminine products. Paper towels and dental floss. These items can get stuck in the sewer pipe and potentially cause a backup.
